## Mail Ballot Instructions for 2021 Local 5 Officers Election

1. Read the instructions carefully before marking and mailing your ballot. Enclosed for you are the following:

- Secret Ballot (with Voting Instructions on reverse side)
- Secret Ballot Ènvelope
- Return postage-paid envelope addressed to UNITE HERE Local 5

2. Full Slate Voting Instructions: A full slate is a group of candidates running as a team. You are not required to vote for a Full Slate. If you choose to vote for a Full Slate (only one), place an "X" mark in the large box next to the name of the slate of your choice and do not vote for any other candidate. If you vote for a slate, no other mark on the ballot purporting to cast a vote for another candidate will be counted.

3. Voting for Individual Candidates: If you do not wish to vote for a Full Slate, do not mark the Slate Box. To vote for individual candidates, place an "X" mark in the box next to the candidate(s) of your choice. Do not vote for more candidates than you are authorized for each position. Voting for more candidates per position will VOID that office portion of your ballot.

4. Do not place your name, initials, or any other identifying information on the ballot. Your ballot will not be counted if it contains any marks from which you can be identified. Do not show your ballot to anyone else.

5. If your ballot package does not contain a Secret Ballot Envelope, or if you make a mistake marking your ballot, you may request a new ballot from the DOL Election Supervisor Gary Gray at (808) 541-2937 or at HON-ElectionSupervisor@dol.gov.

6. Refold your ballot and place the folded ballot inside the Secret Ballot Envelope.

7. Place the sealed Secret Ballot Envelope inside the business reply envelope. You must use the pre-paid envelope to cast your vote. Please do not remove or cross out your name on the business reply envelope. Doing so will void your ballot. Your name on the return envelope will identify you as an eligible voter. Your vote will remain secret because the Secret Ballot Envelope containing your ballot will be separated from the return ballot envelope and mixed with other Secret Ballot Envelopes before it is opened and the ballot counted.

8. Place the business reply envelope with the secret ballot inside a USPS mailbox. Postage is NOT required.

9. IMPORTANT: Mail your ballot in sufficient time for it to be retrieved at P.O. Box 682, Honolulu, HI 96809, no later than 10:00 a.m. on August 27, 2021.
